6. LIFE JACKETS MUST BE WORN AT ALL TIMES WHEN BOAT IS ABOVE IDLE SPEED.
7. NO LIVE BAIT, NO TROLLING, OR USE OF ALCOHOL/DRUGS.
8. BOATS WILL BE CHECKED MORNING OF TOURNAMENT.
9. **A POLYGRAPH TEST WILL BE GIVEN!** FAILURE OF TEST RESULTS IN DISQUALIFICATION.
